- You do not purchase literary material and are not agreeing to purchase or to arrange for purchase of the Material.
- I have retained a copy of the Project and do not expect you to return the copy of the Project I submitted to you. I assume full responsibility for any loss, theft or destruction of such copy while it is in your possession or in transit.
- If any provision of this agreement is deemed to be invalid, it shall be considered deleted here from and shall not invalidate the remaining provisions.

This Agreement may not be changed, modified, terminated or discharged except in writing signed by both you and me. This Agreement, regardless of where executed or performed, shall be governed by, construed and enforced in accordance with the laws of the State of California applicable to agreements executed and to be wholly performed therein, any action shall be brought in such state and I hereby submit to the personal jurisdiction of the courts thereof.
